### A TRADITION OF CELEBRATING STUDENTS WITH CYSTIC FIBROSIS

This year marks the 33rd year of the AbbVie CF Scholarship. The scholarship program was developed to honor those with CF as they pursue goals of higher education. Since 1993, AbbVie has awarded over \$4.1 million in scholarship funds to help students with CF pursue their educational goals.

#### 2025 SCHOLARSHIP DETAILS

- 40 scholars will be selected to receive \$3,000 for use during the 2025-2026 academic year.
- Applicants will be judged on creativity, academic excellence, community involvement, and the ability to serve as a positive role model for the CF community.
- Each of the 40 scholars selected will be given the opportunity to compete for a Thriving Student Scholarship in one of two categories based on level of study. The Thriving Undergraduate Student and Thriving Graduate Student will each be awarded a total of \$25,000 (the original \$3,000 AbbVie CF Scholarship plus an additional \$22,000 scholarship).
- **It is not necessary for applicants to have taken, currently take, or intend to take in the future any medicine or product marketed by AbbVie, and this will not be considered in the recipient selection criteria.**

## ELIGIBILITY REQUIREMENTS

This scholarship is designed for US students with CF pursuing an undergraduate degree (associate/2-year college, bachelor's/4-year college, trade/vocational school) or graduate degree (master's, MD, JD, doctorate) during the 2025-2026 academic year. Applicants must have completed high school or obtained a General Educational Development (GED) certification by or before June 2025.

Students applying for this scholarship must be enrolled in an undergraduate or graduate program in the 2025-2026 school year. Students in their final year of undergraduate study may only apply if they will be pursuing a graduate program in the 2025-2026 school year.

Scholarship funds may be considered nontaxable under applicable federal tax laws. Please direct all questions about tax preparation to your tax advisor.

All prior scholars can apply for the 2025 AbbVie CF Scholarship. However, all prior recipients of the Thriving Student Scholarship (the larger scholarship amount) are ineligible to apply for any AbbVie CF Scholarship again.

Students are expected to behave in a respectful manner toward fellow contestants during all phases of the scholarship, including online and on social media channels. Bullying, discriminating, profane or threatening comments, and/or harassment may result in disqualification.

**Employees of AbbVie and their immediate family members are not eligible. Healthcare providers, including physicians and those who can prescribe medications, and their immediate family members are not eligible.**

Each applicant must be:

- A United States citizen or a legal and permanent resident of the United States
- Diagnosed with CF by a physician
- Enrolled in or awaiting acceptance from an accredited institution (college, university, or trade/vocational school) for an educational program during the 2025-2026 academic year

**Students may submit their application any time during the application acceptance period from April 3 through May 15, 2025.**

## JUDGING CRITERIA TO DETERMINE THE 40 SCHOLARS

A panel of judges selected by AbbVie will evaluate all eligible submissions based on each student's academic record and extracurricular activities, essay, and creative presentation.

40 scholars will be determined by the highest cumulative points awarded by the judges. Please refer to the contest rules to see details on scoring.

Scholars will be notified on or around July 1, 2025, if they have been chosen to receive an AbbVie CF Scholarship, using the contact information provided in this application.

## SELECTION OF THRIVING UNDERGRADUATE STUDENT AND THRIVING GRADUATE STUDENT

Information in this section will be evaluated based on:

- Creativity/originality
- Overall artistic quality
- Impact of visual, verbal, and/or auditory expression

This is where you have the opportunity to showcase your positive outlook, what sets you apart from your peers, what inspires you to live life to the fullest, or anything else that you think will provide a sense of what makes you unique.

This piece can be an additional written work, a piece of art, collage, photograph, song, or video. Please note that once the creative presentation has been submitted, it cannot be reworked or edited.

### IMPORTANT INFORMATION ABOUT YOUR CREATIVE PRESENTATION

- The hard copy of your creative submission must be limited to two 8.5" x 11" pages or appear on a single sheet of poster board (up to 18" x 24"). Video files **no more than 120 seconds** may also be submitted in **WMV, MPEG, or QuickTime** (size 640 x 480) format. Preferred file types for photography include **JPEG, TIF, or PSD 200 DPI** (2000 x 2000) and may be emailed to **info@AbbVieCFScholarship.com**. If photography is submitted via hard copy, please note that images will be scanned in order to be displayed online. If submitting a presentation, PowerPoint files (PPT) must not exceed six slides. All other digital formats, such as interactive Prezis, will not be accepted. If you include your name in your submission, **please only include your first name and first initial of your last name**.
- By submitting your application, you acknowledge that you have obtained permission from all recognizable persons in your submission to utilize their image, likeness, and/or voice for the purpose of this contest, including for display online at **www.AbbVieCFScholarship.com** and any other websites outside of AbbVie's control, such as YouTube, Facebook, or other non-AbbVie sites.
- If you use a copyrighted song or image in your creative submission, please include written permission from the copyright owner in your application. If you are submitting music, please limit your submission to **one** song no longer than 120 seconds. **Use of unauthorized music or images in your application may result in the disqualification of your submission.**
- Past recipients are welcome to reapply to the program; however, they must submit new creative expressions. Please note, however, that all previous Thriving Scholars (recipients of the larger scholarship) will not be eligible to apply for any AbbVie CF Scholarship again.
- **Please do not include any specific brand and/or product shots of medications, including images/references to generic names of medications, in your creative presentation.** This can include identifying names or colors of pills/prescription bottles, and/or brand names of breathing devices. Such inclusion may result in the disqualification of your submission.

### Hard Copy Application:

A completed application must be mailed and postmarked before the scholarship application deadline on May 15, 2025. Applications postmarked after the deadline will be ineligible.

**Mailed applications must also be received within five business days following the close of the application period. Only one application per student will be accepted.**

## 2025 ABBVIE CF SCHOLARSHIP CONTEST RULES

The 2025 AbbVie CF Scholarship ("contest") is sponsored by AbbVie, and is subject to all applicable federal, state, and local laws. AbbVie reserves the right to change, alter, or modify these rules and/or dates at any time without notice. Scholarship funds may be considered nontaxable under applicable federal tax laws. Please direct all questions about tax preparation to your tax advisor.

Scholarship funds may be disbursed over multiple years, as needed.

Forty scholars will be chosen by a panel of judges selected by AbbVie to receive the \$3,000 AbbVie CF Scholarship. Submissions will be judged and ranked using a point system based on the following criteria:

- Academic record and extracurricular activities (assigned a score up to 30 points)
- Essay (assigned a score up to 20 points)
- Creative presentation (assigned a score up to 20 points)

All eligible submissions will be evaluated based on academic record and extracurricular activities. The top 60 submissions will then also be evaluated based on creative presentation and essay to determine the top 40 scholars.

**Under no circumstances will the judges' scores be disclosed to the public. All decisions made by the judging panel are final.**

In the case of a tie, those submissions will be evaluated according to the original criteria by a new judge selected by AbbVie who was not involved in the initial scoring process. The submission with the highest cumulative score by the new judge will be declared a scholar.

Submission guidelines and eligibility requirements are included in the application. By participating, applicants agree to these contest rules and the decisions of the judges, which are binding and final on matters relating to this contest. **It is not necessary for applicants to have taken, currently take, or intend to take in the future any medicine or product marketed by AbbVie, and this will not be a consideration in the recipient selection criteria.**

### Public Voting for the Thriving Undergraduate and Thriving Graduate Students

The overall Thriving Undergraduate Student and Thriving Graduate Student will be determined by the number of valid votes cast by the public (weighted 30 percent) and the cumulative points awarded to each scholar by the judging panel (weighted 70 percent). The Thriving Scholars will be determined using a point system based on the following criteria:

- Public votes (assigned a score up to 30 points)
- Academic record and extracurricular activities (assigned a score up to 30 points)
- Essay (assigned a score up to 20 points)
- Creative presentation (assigned a score up to 20 points)

**Under no circumstances will the judges' scores or tallied votes be disclosed to the public. All decisions made by the judging panel are final.**

In the case of a tie, the tie will be broken based on the student who received the most cumulative points during the initial judging period to select the 40 scholars.

The Thriving Scholars will each be awarded a total of \$25,000 (the original \$3,000 AbbVie CF Scholarship plus an additional \$22,000 scholarship). Applicants will be notified of the results following the closing of the voting period, no later than October 3, 2025.
